- a. On 13 July 2009, SJM Holdings Limited (the “**Issuer**”) granted share options to participants which entitled them to subscribe for a total of 166,700,000 ordinary shares of the Issuer under the share option scheme. The vesting period for all of the share options is six months from the date of grant, except the vesting period for share options in respect of 30,000,000 shares is 1/3 vesting on 13 January 2010, then 1/3 vesting on each of the first and second anniversaries of such date.

- b. On 7 October 2009, the Issuer granted share options to a participant which entitled him to subscribe for a total of 1,200,000 ordinary shares of the Issuer under the share option scheme. The vesting period for all of the share options is six months from the date of grant.

- c. As stated in the announcement of the Issuer dated 24 September 2009, the Issuer and Champion Path Holdings Limited (a wholly-owned subsidiary of the Issuer) (“**Champion Path**”) entered into a bond subscription agreement with Deutsche Bank AG, Hong Kong Branch (the “**Lead Manager**”), whereby the Lead Manager has agreed to subscribe and pay for, or procure subscribers to subscribe and pay for, the bonds to be issued by Champion Path in an aggregate principal amount of HK\$2,000,000,000 (the “**Bonds**”). The Issuer agreed to guarantee payment of all sums payable in relation to such Bonds. Please refer to the announcement of the Issuer on 24 September 2009 for further details.
